Terms of Agreement

Parent Consent:

I agree to have my son/daughter participate in Save Our Youth (SOY). I understand that he/she must obey the established rules and directions by authorized SOY staff or volunteers, or will be asked to leave.

As the parent/guardian of the boy/girl in this document, I give permission to a physician licensed under the appropriate laws of the state of California to administer emergency treatment as in his/her judgment shall be necessary under the circumstance. I understand that I am responsible for any monetary expense that any such treatment may require. Should any illness or accident occur to him/her during boxing, lifting weights, dancing or volunteering or participating in any activities (community, recreational, sports, etc.) at or in relation to the SOY Center, I will not hold SOY Center liable, or their staff, volunteers, director or any person in charge.

In consideration of my child being permitted to enter and/or participate in the Save Our Youth/SOY (aka SOY Center) organization facilities and activities related or otherwise) to engage in any sport, recreational, volunteer or academic activities, participate in the Save Our Youth sports, fitness, boxing, academic, community services and recreation programs and for other purposes, including but not limited to observation, use of facilities or equipment or participation in any way, the undersigned for himself or herself and his/her child in any personnel representative, heirs and next of kin, hereby acknowledges agrees and represents that he or she has or immediately upon entering will inspect such premises and facilities. It is further warranted that such entry to facilities for observation, participation or use of said facilities by my child constitutes acknowledgement that such premises and all facilities and equipment thereon have been inspected and that the undersigned finds and accepts same as being safe and reasonably suited for the purposes of such observation or use.

In further consideration of my child being permitted to enter the facilities for sport, dance, academic or recreational volunteer and boxing activities and other purposes including but not limited to observation, use of facilities or equipment, or participation in anyway, the undersigned hereby agrees to the following:

1) The undersigned hereby releases, waives, discharges and covenants not to sue (i.e. file a lawsuit) the Save Our Youth/SOY (aka SOY Center) organization, their departments, directors, officers, board members, employees, supporters (i.e. donors, grantor and/or supporter) volunteer and agents (herein after referred to as "releases") from all liability to the undersigned and his/her child of the undersigned whether caused by negligence of the releases or otherwise while the child of the undersigned is in, upon or adult the facilities for sport, recreational, dance, community service, volunteer or boxing activities or any other purposes identified above.

2) The undersigned hereby agrees to indemnify and save and hold harmless the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the child of the undersigned in upon the facilities for the sport, academic, recreational, boxing or dance activities or in any way observing or using any facilities or equipment of the releases whether caused by the negligence of the releases or otherwise.

3) The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of the releases or otherwise while in, about or upon the facilities for sport,

recreational, academic, special event, community service, volunteer 0, boxing activities or any other purposes identified above.

The undersigned further expressly agrees that the foregoing release, waiver & indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
